For the 18's division, all players must be at least 18 years old by or on February 11<sup>th</sup> for liability reasons.

For the 30's division, players must be at least 30 years old by December 31, 2017.

For the 40's division, players must be at least 40 years old by December 31, 2017

For the 50's division, players must be at least 50 years old by December 31, 2017

For the 57's division, players must be at least 57 years old by December 31, 2017. **(This is a 8 v 8 tourney)**
