- ALL** players must submit a signed release waiver for the Fall 2021/Spring 2022 season, a wallet-sized, legible photocopy of her Driver's License, which will be used to generate a player ID card, and an individual check in the amount of **\$30.00** to the registrar noted below in order to play in the O'40s Division. The check must be made payable to OCWSL.
- Fall registration deadline is August 1, 2021.** Additional players may register after that date with the appropriate forms as described above. New players can be added throughout the season.

I have elected to participate in the Orange County Women's Soccer League (OCWSL), and I acknowledge that participation in the sport of soccer involves risk of injury. Therefore, I release OCWSL and any City in which I participate in a game sanctioned by OCWSL or any affiliate association involved in OCWSL activities from all liability or responsibility from an injury I may sustain while participating in this league.

In consideration for being allowed to participate, in any way, in OCWSL and related events and activities, the undersigned:

- Agrees that prior to participating, she will inspect the facilities and equipment to be used, and if she believes anything to be unsafe, she will immediately advise her coach or representative of such condition(s) and refuse to participate.
- Acknowledges and fully understands that by participating she will be engaging in activities that involve risk of serious injury, including permanent disability and death, and severe social and economic losses which might result not only from her own actions, inactions or negligence of others, the rules of play, or the condition of the premises or of any equipment used. Further, that there may be other risks not known or not reasonably foreseeable at this time.
- Assumes all the foregoing risks and accepts personal responsibility for the damages following such injury, permanent disability, or death.
- Releases, waives, discharges, and covenants not to sue OCWSL, its affiliates, their respective administrators, directors, agents, coaches, and any other employees or volunteers of the organization, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event, all of which are herein after referred to as "releasees" from demands, losses, or damages on account of the injury, including death or damage to property caused or alleged to be caused in whole or in part by the negligence of the releasee or otherwise.
- Understands that while OCWSL does maintain liability insurance, this insurance does not include insurance for bodily injury, liability for loss or damage to personal possessions, but that such insurance is the responsibility of said player.
- I, the undersigned, do hereby consent and agree that Orange County Women's Soccer League together with its affiliates, directors, officers, and employees, (the "League"), or agents have the right to my (and my child/children, if applicable) image, likeness and sound of voice for photographs, videotape, and/or digital and to use these in any and all media, now or hereafter known, and at the League's discretion for marketing, advertising, etc. I further consent that my name and identity (including my child's/children's name and identity, if applicable) may be revealed therein or by descriptive text or commentary. I do hereby release to the League all rights to exhibit this work in print and electronic form publicly or privately and to market and sell copies. I waive any rights, claims, or interest, I may have to control the use of my identity or likeness (including my child's/children's identity or likeness, if applicable) in whatever media used. I understand that there will be no financial or other remuneration for photographic, videotape, and/or digital representations of myself, either for initial or subsequent transmission or playback. I understand there is no time limit on the validity of this release nor is there any geographic limitation on where these materials may be distributed. I represent that I am at least 18 years of age. I have read and fully understand the foregoing statement and am competent to execute this release. (\*updated Fall 2021\*)
